Health Guarantee/Contract

A non-refundable deposit of \$500.00 is required to hold a puppy of choice. If the deposit is made before a litter is born, the deposit may be transferred to another litter if there is not a puppy in the litter of the buyer's liking. Deposits may be made by Cash,Venmo, Zelle, or PayPal friends and family. The total price due must be paid in full before the delivery of the puppy or paid in cash at pick up.

Abundant Joy reserves the rights to "FIRST" pick from each litter if so desired, even when deposits are made.

Shipping

Shipping is available via ground transport. Shipping expenses will be paid by the buyer and paid in full 7 days before the puppy will be shipped. The puppy will come with a Missouri State health certificate for shipping.

My Guarantee

Your puppy will have had all the necessary vaccinations and deworming at the time of shipping, and will have been examined by a licensed Veterinarian prior to shipping. I guarantee, to the best of my knowledge, that I am sending you (the buyer), a healthy puppy.

Buyer's Responsibility

Owning a puppy means occasional trips to the vet. You (the buyer), are responsible for all the costs of the trips. Please take your puppy to the vet within 10 days of arriving home for an exam or this contract is VOID. It is up to you to provide your puppy with the routine preventive care it needs. Annual physical exams by a licensed veterinarian and following the veterinarian's guidelines for vaccinations and deworming are the sole responsibility of the buyer.

Abundant Joy will not be responsible for any medical expenses incurred.

Health Guarantee

During shipping, puppies can become stressed by the change in environment. Minor problems such as diarrhea, coccidia, upper respiratory, kennel cough, etc. may occur and must be treated. These conditions are the responsibility of you (the buyer), not the seller, and should be checked by a licensed Vet. These and other minor health problems are not covered by this guarantee. Minor problems that can be cured by medication are not covered by the guarantee. Any existing conditions listed in advance will not be covered by this guarantee. This guarantee does not include any injuries or problems the puppy develops due to neglect or abuse by the new owner.

Your puppy is guaranteed for 2 years of age against fatal and life altering diseases. This includes hip dysplasia; heart and liver problems of life-threatening or altering nature are also included. In the unlikely event this occurs, I must be notified within 48 hours of the licensed Verteriniarian's determination. At your(the buyers) expense, I require **TWO** reports from **TWO UNASSOCIATED LICENSED** Veterinarians, both stating the same diagnosis. If the puppy is diagnosed with hip dysplasia, I require copies of the x-rays. There are certain disorders which may be caused by environmental conditions. For example: allergies, thyroid dysfunction, mange, and autoimmune disorders are not covered by this guarantee.

Abundant Joy can not and will not guarantee the color or size of puppy as an adult or final temperament as an adult as this can be environmental also after leaving Abundant Joy. **If at any time the buyer can not keep the puppy/adult, we reserve the right to have the first option to buy the puppy/adult back, if this is not an option at the time then the buyer can rehome said puppy/adult.** A returned puppy must be returned to the seller in good condition other than the specific problem. In the unlikely event that the puppy should die within the 2 year time frame, you (the buyer) must pay to have a necropsy done on the puppy to show the reason for the death. The necropsy report must show, without a doubt, the reason of death was congenital. I will only replace the puppy with a puppy from the next available litter. NO REFUNDS WILL BE GIVEN. The replacement puppy may or may not have the same parents. No puppy replacement will be given if the original puppy has been euthanized, spayed or neutered without our permission. Any physical problem occuring from injury to the puppy is not guaranteed. You (the buyer) are responsible for transportation cost to and from the seller on a replacement puppy.

This Guarantee only applies to the original owners of the puppy. If the puppy is sold to another party before the age of 1, this guarantee is **VOIDED**. If there are any disputes or legal matters having to do with this sale, they must be resolved in NEWTON County.
